In order to ensure the continued success of the event and the safety of those in attendance, the Chamber of Commerce has established the Vendor Application Procedure and Requirements listed below. *Please read and follow directions carefully as an incomplete Vendor Application will be denied*. Step 2: Adams County Health Department Registration (Food Vendors ONLY)	Attach a copy of ACHD Food Service Permit receipt or submitted application (applicable vendors) to this application.			
Register with the Adams County Health Department and purchase a Permit to Operate One Temporary Food Service Establishment (\$50 per day/per event, applicable vendors). Mobile food vendors must possess Permit to Operate a Mobile Food Service Establishment. The ACHD Temporary Food Service Permit Application can be found on page 5 of this packet.
